The building works well structurally and technically. The thickness of the roof over the promenades seems unrealistic. Clear height of the saunas should be lowered somehow to keep the hot air at the user's level.

III. OVERALL EVALUATION, QUESTIONS FOR DEFENSE, CLASSIFICATION SUGGESTION

The author perfectly utilized the potential of the land on the bank of the Vltava and placed on it a monumental city palace. The building reminds me character of the Swimming Stadion in Podolí. The distinct architecture of the building combines a minimalist approach with a reference to the ex-industrial character of Holešovice and very successfully connects the city with the river.

The interior spaces are generous, appear optimistic and are enlivened with interesting ideas - volumes of saunas in the leisure pool, a colonnade along the pool halls and outdoor pools... The brick "chimneys" are a bit formal, but why not. Contrast between them and the white color of the building works great.

The objections are following:

- Where are the boundaries between the spa and the surrounding public space. Are the promenade and the monumental exterior stairs to the river public, or are they part of the spa?
- There are not any showers designated to the saunas. It should not possible to enter the pools without taking a shower.
